A RESOLUTION AMENDING THE ENTERPRISE ZONE AGREEMENT BETWEEN THE CITY OF GREEN, THE COUNTY OF SUMMIT AND BEST MOLD AND MANUFACTURING, INC., AND DECLARING AN EMERGENCY.

WHEREAS, by Resolution 2006-R54 City Council approved an Enterprise Zone Agreement between the City of Green, the County of Summit and Best Mold and Manufacturing, Inc.; and

WHEREAS, in August 2007, the Tax Incentive Review Council reviewed the Enterprise Zone Agreement with Best Mold and Manufacturing, Inc. and recommended an amendment to the agreement due to delays in the construction of the Company's planned expansion; and

WHEREAS, the agreement states that the construction project would begin on January 1, 2007 and be completed by November 15, 2007. The agreement outlines a 48-month Job Creation Period beginning January 1, 2007 and ending December 31, 2010. Further, the agreement calls for the tax exemption to commence on January 1, 2008 and end on December 31, 2012; and

WHEREAS, the City wishes to adopt the recommendation of the Tax Incentive Review Council and amend the Enterprise Zone Agreement with Best Mold and Manufacturing, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT AND STATE OF OHIO THAT:

#### **SECTION ONE:**

City Council authorizes the Mayor to enter into an amendment to the Enterprise Zone Agreement between the City of Green and Best Mold and Manufacturing, Inc. amending the agreement as follows:

Project Construction Period:

January 1, 2008 to November 15, 2008

Job Creation Period

January 1, 2008 to December 31, 2011

Tax Exemption Period

Tax Year 2009 through Tax Year 2013

City Council directs the Mayor to assure that a proper amendment is executed by the parties consistent with this Resolution.

### **SECTION TWO:**
