A RESOLUTION AUTHORIZING THE CITY OF GREEN TO OFFER FOR AUCTION OR SALE PROPERTY NOT NEEDED FOR ANY MUNICIPAL PURPOSE, AND DECLARING AN EMERGENCY.

WHEREAS, City Council authorized the sale of unneeded items on ebay by Resolution 2008-R37; and

WHEREAS, the City desires to dispose of the property by public sale and/or auction because it is not needed for any municipal purposes; and

WHEREAS, many of the items potentially have a value in excess One Thousand Dollars (\$1,000.00).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

SECTION ONE:

City Council authorizes and directs the public sale and/or auction of the property identified in Exhibit "A".

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:



Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.




